

### ***From the Board...***

Please find an article from the Colorado State Extension provided to the Master HOA regarding the impact weather has on our trees. Please take the time to review it and take action to ensure the health of your trees this spring.

### ***Design Review Request (DRR)...***

A Design Review Request form must be submitted and approved, prior to doing the work, for any exterior changes such as painting your home, redoing landscaping, or building a patio cover. Please fill out the DRR form and submit it to Flagstaff Management via mail or email. If you are submitting a painting request, please see the sections about painting requests for additional information. **You can find the Design Request Review form and guidelines under Prairie Hawk HOA website at:**

When submitting any landscaping or building requests, please be specific and include a plot plan and drawing with the DRR form.

### ***House Painting...***

Many homeowners have started painting their homes - and they look great! However, many homes in the neighborhood are still in need of painting; the original builder's paint is fading and failing. With Colorado's elements, it is recommended by local painters to repaint within the first seven to eight years of a new homes construction. New paint will protect your investment and neighborhood property values!

You are not required to keep the existing color scheme; however, if you choose to change the paint color, the color must first be approved by

the Design Review Committee **before** proceeding.

***Painting your home?*** If your answer is yes, then here is what you need to do long **before** you paint:

**1:** Choose your colors that you wish to paint. Be sure they are different from your neighbor's house colors on either side of you and directly across from you. If you choose to paint your house with the same color as the original build and are not sure what that color is, you can visit the Flagstaff management office to obtain the corresponding color. Please call Flagstaff at 303-682-0098 to make an appointment to see the builder color schemes.

**2.** Submit two (2) copies of those colors (paint chips) to Flagstaff Management along with the **Design Review Request Form**. These can be found at the HOA website at:

NOTE: If you are painting your house the same color as the original paint, you are not required to submit a Design Review Request form, but the Board is highly recommending you do to alleviate any question with the color, given new paint looks so much different than faded paint. DRR's request for the same paint color will be processed quicker than if you are changing colors.

**3.** Wait for your approval **BEFORE** you set a date with your painter. The Covenants allow up to 45 days to reply, but this timeframe is generally much shorter.

### ***Painting Fences...***

Many of our fences are more that 10 years old and need a fresh look. If your garage is in the front of your house and you would like to change the color of your fence, please make sure to fill out a Design Review Request form to



obtain approval **prior** to doing the work. If your garage is in the alley, the approved color of your fence is **Diamond Vogel, Fox Meadows Yellow, F6406-93/BT1504**. Please use only the approved fence color.

### ***Maintain Yard...***

As the weather is turning warmer, please remember to maintain your yard and landscaping. Please do not blow grass clippings onto the sidewalk or into the street. Please replace dead trees and bushes, water the lawn, mow your lawn, pull weeds, pick up trash, etc. This will help keep the neighborhood attractive for all residents.

### ***Trailers, Campers and Boats***

Please remember that trailers, boats, and motorhomes are not permitted to be parked permanently within the community. Boats or campers may be parked temporarily as required for loading and unloading for 72 hours maximum. Such vehicles must be moved from the general area unless approved – in writing by the board. Such vehicles or trailers may be stored only within garages with the garage door closed. ### ***Speeding on Deerwood...***

Flagstaff Management has received several complaints about cars speeding on Deerwood. Please remember the speed limit throughout the neighborhood is 25 miles per hour.

**Trash Cans:** cannot be placed out for collection prior to 4:00 P.M. of the day before the scheduled collection and returned by 8:00 P.M. on the day of trash collection. You must

place your trash containers in your garage or behind your fence.

**Dues Payments** – When you are making a payment for your dues, please make your check payable to **PRAIRIE HAWK HOA**. Make sure you notify Flagstaff Management, if you have a change of address or phone number. If you are unable to pay your dues, please make sure to contact Flagstaff Management to set up a payment plan, so you are not turned over to the attorney for collections.

### ***Walking your dog...***

Please remember it is the pet owner's responsibility to clean up and properly dispose of pet waste. Doggy bags are available along the walkway areas for those who may have forgotten to grab one on the way out the door. Remember to leash your dog while walking it.

**Bulletin Boards...** This is a reminder regarding the Bulletin Board policy. Homeowners can have advertisements posted on the boards. Ads the size of a business card will be accepted for resident's commercial purposes (i.e. your business or service). Ads the size of a sheet of paper will be accepted for non-commercial purposes (i.e. garage sales, etc.).
